# SOCIAL EXPENDITURE MONITOR

## DATABASE MANUAL, JORDAN OVERVIEW

- The manual is a reference to better understand the building of indicators of social expenditure for Jordan. The definition of indicators is based on ESCWA's Social Expenditure Monitor for Arab States (ESCWA 2019), tailored to Jordan context.
- The purpose of this manual is to provide guidance for users to construct the indicators of SEM based on programs and projects and their respective codes in Jordan.
- The methodology (codes) used to generate the indicators in Jordan context is derived from the Jordan Budget Law, from different line ministries (Annex I).

# Economic Classification Categories

As the definition of capital expenditure in the budget is not in accordance with the technical definition, to compute the total capital expenditure, the technical definition of capital expenditure was used which refers to expenditure on non-financial assets. The dataset of the SEM is, thus, composed of (1) current expenditure; (2) expenditure on non-financial assets. Expenditures from activities and projects were aggregated to arrive to total current expenditures and total expenditure on non-financial asset for each indicator and dimension.

**Table 1** presents a snapshot of the Economic Classification Categories available in Jordan’s Budget. Highlighted in grey are the components used to compute the total capital expenditure. It should be noted that only an example of each Item was provided in this chart.

**Note:** Multiple beneficiary categories reflect the expenditures that were not allocated to a single key beneficiary due to insufficient information on the expenditures in the budget. Three categories of Multiple population groups were identified while mapping Jordan's budget to the SEM framework, which are:

- (a) Multiple beneficiary categories (01,02,03,04,05,06) : Total Population
- (b) Multiple beneficiary categories (Female(02,03)): Female young and adults
- (c) Multiple beneficiary categories (02,03): Young and Adults

In the following tables, the Jordanian public ministries/entities with contributions to the seven dimensions of the SEM are identified with their corresponding programs, activities/projects, and items (if needed). While in some cases, the program maps entirely to a specific indicator, i.e., all the activities/projects of the program map to the indicator, in other cases, it is disaggregated between different indicators. Therefore, in the tables, whether the program maps entirely to the indicator is identified. If not, the codes of the activities/projects within the program that map are specified. In some instances, however, the activities/projects do not map entirely to the indicator; thus, the codes of the items that compose these activities/projects that map are indicated. The main SEM beneficiary corresponding to each expenditure is also indicated.
